FOREWORD

The purpose of this Code is to encourage high ethical standards in tendering in the construction industry, in the belief that significant benefits will flow to the entire community through the delivery of higher productivity, high quality construction work, better working conditions and elimination of malpractice. It constitutes a statement of the ethics which underline best practice tendering procedures. It imposes an obligation on all those parties to refuse to condone unethical behaviour by others in the industry.

Inherent in adoption of this Code is a willingness to deal only with industry organisations and personnel whose standards of performance and behaviour conform to those expected by this Code

Interim Australian Standard

Code of tendering

1 SCOPE This Code sets out the ethics and the obligations of the principal and contractors in tendering in the construction industry. A separate Code covers the selection of consultants providing professional services.

2 APPLICATION This Code applies equally to principals, their agents, contractors, subcontractors and suppliers and their association and professional organisations.

3 DEFINITIONS

3.1 Construction industry—includes all building, refurbishment, maintenance, civil engineering, process engineering, mining and heavy engineering projects. It excludes cottage construction.

3.2 Tenderer—any party submitting tenders, including head contractor, subcontractor and supplier.

3.3 Principal—any party inviting and receiving tenders. A principle may include head contractor or subcontractor.

3.4 Intellectual property—all copyright, patents and all rights in relation to inventions, registered and unregistered trademarks (including service marks), registered designs, and circuit layouts, and all other rights resulting from intellectual activity in the industrial, scientific, literary or artistic fields.

4 ETHICS This Code is based on the following principles:

- (à) Tendering at all levels in the industry shall be conducted honestly and in a manner that is fair to all parties involved.
- (b) Parties shall comply with all legislative obligations including those required by trade practices and consumer affairs legislation.
- (c) Principals shall have regard to the costs of bidding and the number of tenderers.
- (d) Tenderers shall bid only where they intend to carry out the work if successful.
- (e) Principals shall only call for tenders after they have made a firm commitment to proceed with the project.
